- Slightly ditch margin for optimal scanning
- **DO NOT** mark margin
- **NO** die spacer
- **NO** die sealer

Client agrees to indemnify and hold Center harmless from and against any claim or demand, including reasonable legal fees, made by any third party due to or arising out of client's use of said restorations. Center does not guarantee the performance of independent carriers. Client acknowledges that limitations on liability are a usual part of business-to-business relationships, and a common practice in the dental industry, and that such limitations as specifically stated above are relied upon by Center when establishing the cost of providing restorations.
